SAILING INSTRUCTIONS

Amendment #1 of 21 Dec 21 (changes in italics)

1. Rules

- 1.1 This is NOT a race. RRS do not apply but all other regulations relevant to marine traffic do apply, together with good practice and corinthian ethos.

2. Notices to Competitors

- 2.1 Notices to competitors will be posted on the official notice board located at the entrance to the Cowes Corinthian Yacht Club.

3. Changes to Sailing Instructions

- 3.1 Any change to the sailing Instructions will be posted before 0900 on the day it will take effect.

4. Signals Made Ashore

- 4.1 All signals including postponement or abandonment will be broadcast by VHF Channel 37A. No flag signals will be used.

5. Schedule of Event

- 5.1 Sunday 26 December 2021:

High Water Portsmouth	16:02 GMT 4.0m
Warning Signal	11:00 GMT

6. Class Flags

- 6.1 No Class Flags will be used.

7. Courses

- 7.1 The Course will be crossing the start line to the south, proceeding up river to Folly Reach where the Club RIB will be positioned. Boats will round the RIB twice to starboard and on the **second** rounding will collect a token from the RIB crew. The token is to be handed to the Organising Committee on return to the Club after finishing.
- 7.2 If conditions so dictate the course may be changed by the Organising Committee prior to the start, in which case the RIB will be positioned in the vicinity of *Kingston Marine Services*.

8. Areas that are Obstructions *and other restrictions*

- 8.1 Boats shall avoid close quarters with any commercial vessel.
- 8.2 Boats shall not anchor or kedge in the Cowes Harbour fairway.
- 8.3 Boats shall keep a good look out for ferries and commercial traffic.
Note that the Chain Ferry is expected to be in operation and that it has priority over other traffic.
- 8.4 *To comply with CHC Bye-laws, engines should be kept running while in the river. Since this is not a race, boats may motor or motor-sail at any time in the interests of safety.*

9. The Starting Line

- 9.1 The starting line is between the CCYC Club flagpole and No 6 Harbour Buoy. The Inner Distance Marker is Lallows fuel berth

10. The Finishing Line

- 10.1 The finishing line is between the CCYC Club flagpole and No 6 Harbour Buoy. The Inner Distance Marker is Lallows fuel berth

11. Individual Recalls

- 11.1 Sail Numbers of individually recalled boats may be broadcast on VHF as soon as practical. Failure to broadcast the sail numbers will not be grounds for redress.

12. Radio Communications

- 12.1 The Event Committee will communicate with competitors on VHF channel 37A (M1).
No flag signals will be used.

13. Retirements

- 13.1 Boats that have retired shall notify the event committee, on VHF Channel 37A and receive an acknowledgement at the earliest opportunity.

14. Protests and Requests for Redress

- 14.1 Protests will not be entertained.

15. Scoring/Results

- 15.1 Boats will not be scored.

16. Prizes & Time Limit

- 16.1 Prizes will be awarded to the boats returning the first three tokens drawn in the Club Bar after the Time Limit. The Time Limit for submitting tokens is 15:00.

17. Risk Statement

ALL PARTICIPANTS ARE REQUIRED TO WEAR PERSONAL BUOYANCY WHILE AFLOAT. Failure to do so will result in disqualification without appeal.

The responsibility for a boat's decision to participate in an event or to continue is hers alone.

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- 17.1 They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- 17.2 They are responsible for the safety of themselves, their crew, their boat and their property whether afloat or ashore;
- 17.3 They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- 17.4 Their boat is in good order, equipped to sail in the event and they are fit to participate;
- 17.5 The provision of an event management team, committee boats and other officials and volunteers by the event organizer does not relieve them of their own responsibilities.
- 17.6 The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.
- 17.7 It is their responsibility to familiarize themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.
- 17.8 By entering or taking part in this event all competitors agree to comply with all guidance and regulation issued by HM Government and the RYA in connection with Covid-19.
